Welcome Susan Ramsey, lives on Holland—has been following process of Strategic Housing Plan roll-out. Concerned with affordable housing. When she read the plan... only 300 units in next 5 years. Seems inadequate.

Accept minutes from last month's meeting:

Treasurer's report from Paul:

Current balance: \$1480.75 general fund total

(\$172.23 deposits were from annual meeting donations and contributions "sitting around.")

David moved to accept treasurer's report.

2nd, Nancy.

Verbal vote.

Treasurer's report accepted.

Planning Committee report-Paul Ditson

He has spoken with people and leaders in various organizations to put forth our concerns to the City about the Lakewood Strategic Housing Plan (LSHP).

Paul has ideas.

There are items in the housing plan that are a cause of concern. Some items are *missing*.

Once approved at the City level, it will be used by the City as guidance, so we need to get important items inserted.

We can voice our concerns as individuals and as a group.

Draft LSHP online comments window extended to June 30th.

It's a "Commission" not a committee.

6 members in the committee including the mayor.


If it passes out of committee, it will require 4 more votes on council.

It can still be revised. Once at Council, amendments can be proposed.

No public comment allowed at meetings. Comments taken through Lakewood Speaks and email, etc. Does not currently discuss specific "changes" to Zoning, but it is mentioned. For example, Page 9 of the LSHP reports that at the Community Open House, "Residents shared ideas with staff. Staff

summarized 58 total comments received from the community into three overlapping themes (shown in Figure 1). Of the 58 comments received, most comments (37) expressed support for or offered an idea to make housing more affordable in Lakewood. Ten residents opposed making changes to policy and zoning that could change single-family residential only neighborhoods." (Lisa says, "...the Lakewood planning department is great at making up numbers! They need to be reminded that the lack of a comment and (or) the offer of an idea does not automatically become an "expression of support".)

The Plan did note that one of the "most liked" housing strategy ideas was "Continue allowing peaceful single-family zoning so people aren't packed in like rats. Many of us have spent our lives working for our homes."
