11/13 Council Regular Meeting: resolution: Strategic Housing Plan (tentative)

We want to present OUR document to City Council at the Study Session and at the regular mtg.

The City Manager's office sets the agenda. To get something on the agenda we need a councilor to ask for it to be added to the agenda, preferably from our Ward.

At regular meetings you get to speak for 3 minutes.

Every other week are Study Sessions, but they have an agenda you must stick to.

The City developed the new SHP and expected to approve it in July. But people had objections, so they revised the plan in July and a new version was released.

The City missed the September 1<sup>st</sup> deadline. Payment for the Plan is now coming out of the General Fund. (have not verified this)

We could add verbiage that we represent the interests of our neighbors.

We haven't seen the latest revision, so we need to wait before we send our letter.

David suggests we send our letter at 5 p.m. on the Friday before the Council Meeting. Councilors MUST read it but doesn't give Staff time to do "bad things."

We want the City to know this is NOT how you do outreach.

We (the neighborhood associations) want to be recognized as a stakeholder so we can give input this time!! Paul and others requested this at the last city meeting.

Strategy #1: 1 person reads our Joint Statement at the final meeting.

Other groups have different issues; parking; density—the 2015 comprehensive plan has been working well and its goals have not been completed, so why are they back at the trough?

Do we support our Joint Statement?

David moves that we approve the Joint Statement.

### **September Update:**

City Council will discuss an updated draft of the Strategic Housing Plan during an Oct. 16 Study Session. Staff is currently working on the draft plan to provide an updated version to City Council for that meeting.

## **Project Background**

Housing affordability has become a major challenge across the nation. Historically, Lakewood has been a relatively affordable housing market, but now residents are facing rising housing costs that have only been exacerbated by a tight Colorado housing market, COVID-19 pandemic, and inflation. As of 2022, the average sale price for a home in Lakewood was approximately \$733,000 and the 2022 average rental price is rising to \$1,891. Approximately 60 percent of all Lakewood renters and 20 percent of all Lakewood homeowners are paying more than 30% of their annual



income on housing costs, which is considered unaffordable by the U.S Department of Housing and Urban Development.
